- **Sell Del Mar decals** in shack for \$5.00. One free decal per membership. Sue to send out letters with decals asking for donations. Need to pay Del Mar Boys Soccer for decals.
- **Basketball snack shack** – Cathie Roeder assigned duties to volunteers (open/close/supplies, etc). Martha Contreras is collecting volunteers to work the shack during games. Cathie is requesting a small freezer for burritos, etc. Need 2 more keys (Eric has requested new keys) No shelves until all construction is done – after winter break. First scrimmage game for girls is Nov 23.  
*Sue motioned to approve small freezer for the basketball snack shack up to \$300.00. Liz 2nd motion. Motion Approved!*
- **Track Invitational March 26, 2011** – *Cathie motioned to approve funds request of \$1,200 for track meet awards. Sue 2<sup>nd</sup>, Motion Approved!* Don's Club takes entire gate profits this year to reduce \$5,220 Timing System debit. Snack shack is ours to cover also.
